Call to Order: A quorum was established with three (3) out of five (5) Board members present to hold an Open Session Meeting. The Open Session was meeting held at Cimarron Springs Middle School. The session was called to order at 7:05 PM.

Minutes: A motion was made by Margaret, seconded by Dana, and carried unanimously to approve.

Guest Speaker, Tony Santillan – Stillwater Landscape: Tony gave an update about current landscape items:

- Water on all trees has been turned off.
- There are issues with the poly line irrigation needing to be replaced with PVC
- Currently irrigation timers in common areas are set for 10 minutes
- Sprinklers are turned off for rain
- There is a system called Weathermatic that automatically controls water vs weather.
- Park by parcel 6 grate was left uncovered and a child fell into a hole, uninjured.
- Side of cotton Ln Phase II is running off our water line for the past months. The controller is now locked. Mike to write letter to Surprise Farms II stating water will be shut off.

Financial Report: The October financials were reviewed by Mike Swift. There were high expenses due to tree trimming from storm damage. A motion was made, seconded, and carried unanimously to accept as presented. In the future, the board does not need the full financials, only income statement and balance sheet.

- Homeowner had a question about why Parcel 8 was changed from brick to asphalt. Bricks were a problem since the developer would not repair. Estimates on brick repair were over \$1,000,000. A committee was established, consisting of residents, who met with vendors and decided asphalt was the best solution.
- A homeowner asked what it would take for Parcel 8 to leave and establish its own HOA.
- A homeowner noted there was garbage sometimes found on the property.
